- **The Discount taken for prompt payment of taxes may not exceed \$400.00 per month, per taxpayer regardless of the number of retail locations in the City of Hoover.**
- A remittance for the total amount should be submitted on a monthly basis unless you have requested and been approved for a different filing frequency.
- Any credit for prior overpayment must be approved in advance by the City of Hoover.
- No duplicate or replicated forms acceptable except with prior approval of the City of Hoover.
- Seller must file timely returns, even when no taxes are due.
