If I am registering a minor for a sporting program, I further acknowledge that I am the parent/guardian of the minor registrant and have the authority to execute this release on his/her behalf.

I, on behalf of myself/the minor registrant, understand that I/the minor registrant participate(s) in the sporting program for which registration is submitted (the "Program") at my/his/her own risk. Recognizing the possibility of physical personal injury or death associated with the my/the minor registrant's participation in the Program and in consideration of the City of Hoover ("City") and/or the Public Park and Recreation Board of the City of Hoover ("Board") accepting my/the minor participant's registration for the Program, I, on behalf of myself/the minor registrant, agree to assume all risks of bodily harm and hazards (whether foreseen or unforeseen) to myself/the minor participant from Program participation of any sort as well as other events/programs sponsored by the City/Board and/or hosted at a Hoover City Park or Facility.

I, on behalf of myself/the minor registrant, do hereby waive, release, and agree to indemnify and hold harmless the City and the Board, their officials, affiliated organizations, sponsors, employees, instructors, volunteers, officials, partners, and associated personnel ("Released Parties") in their official and personal capacities, from any and all injuries, claims, demands, suits, liability and costs for personal injury, medical expenses, attorneys' fees and any other expenses arising out of or resulting from my/the minor registrant's attendance and/or participation of any sort in the Program and/or in any City athletic league, at the Hoover Recreation Center, at the Hoover Metropolitan Sports Complex, at any facility utilized by the City for Program purposes, and/or at any other Hoover owned/operated facility.

I, on behalf of myself/the minor registrant, agree to abide/ensure that the minor registrant abides by all rules and policies of the City and Board. I understand that my/the minor registrant's failure to abide by such rules and policies may result in my/the minor registrant's suspension from participation at the Hoover Recreation Center, at any facility utilized by the City for Program purposes, and/or any other City and/or Board owned/operated facility.
